Sir / Madam,

Apropos the captioned subject, I am directed to inform you, the proposal for approval of appointment to the post of Honorary Health Workers (HHWs) as per vacancy notified as on 01.06.2023 has been accorded by the competent authorities of UD & MA Department.

An additional panel for any subsequent vacancy has been also approved by this Department. The additional panel is remain valid for a period of 1 (one) year from the date of communication of this approval letter. **However, you are requested not to engage any candidate from this additional panel list for any subsequent vacancy in the post of HHWs, without prior approval from SUDA.**

In this connection you are requested to take the following action:

- (1) Display the names of the selected candidates as well as additional panel list mentioning the validity of the panel in the Notice Board of the ULB for information and issue offer of engagement to the selected candidates with a request to report for joining to the post of HHW.
- (2) The entire process must be completed within 15 (fifteen) days from the date of issuance of this approval letter with intimation to Director SUDA for office record at sudawbhealth@gmail.com.
- (3) The candidates shall be engaged to the post of HHW by the ULB on monthly honorarium of Rs. 5,250 (Rupees Five thousand Two hundred Fifty only) per month.
- (4) Monthly honorarium of the newly recruited HHWs will be released in due course.

- (5) The engagement shall be made for a period of 1 (one) year from the date of joining of the respective HHW and may be extended further on the basis of satisfactory performance and obtaining approval for extension from the UD & MA Department.
- (6) The entire process from the issue of offer of engagement and till joining and acceptance by the Municipal Authority must be reported at SUDA-Health Management System Portal.
- (7) It appears that, documents received from the ULB, out of total 251 (two hundred fifty one) applications received, 120 (one hundred twenty) applications have been rejected by the Selection Committee. ULB are requested to preserve the list of ineligible candidates mentioning the reasons of rejection for record.
